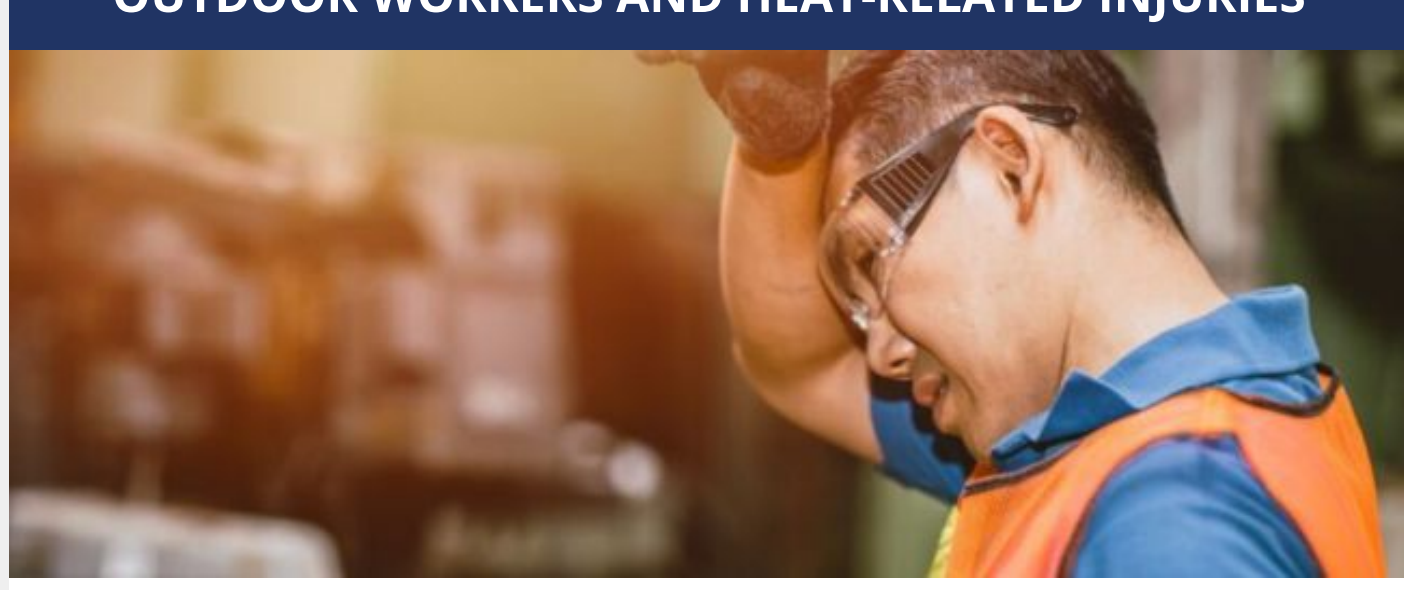


Who Is the Most At Risk of Suffering a Burn Injury at Work?
